Developmental Services LFSVA offers a wide continuum of care for individuals with intellectual and developmental disabilities so that they may live in their preferred community setting. Our services, which include group homes, day support, adult foster care (Family Care Homes) and in-home support, use a person-centered approach that helps individuals meet their medical, dietary, behavioral, personal care and daily living needs, as well as achieve the maximum degree of independence. During this fiscal year, we added skilled nursing services. All services are for adults 18 years of age or older, except in-home support which is provided to all ages. Services are available in more than one-half of Virginia's cities and counties. We now have 194 Family Care Homes and during the year ended June 30, 2017 we helped 389 individuals have fuller, more complete lives.

### **Form 990, Part III, Line 4b:**

Minnick Schools - LFSVA Minnick Schools, located in Roanoke (2 sites), Harrisonburg, Wytheville, Wise and Bristol, work with public schools in 34 localities. During the 2017 school year we helped 249 students reach their academic and behavioral goals. And, 17 children were able to transition back to their home schools. All Minnick Schools offer individualized instruction and the staff works closely with the public schools that place the students, and also with the students' families. A rounded curriculum is aligned with the state Standards of Learning. In four locations we offer students the opportunity to work in a PAES lab, a vocational classroom that helps students prepare for the world of work. With the goal that students will transfer their new behavioral and life skills from the classroom to home and from home to the community, we give children many opportunities to learn and practice. Our autism program offers individualized instruction geared to the unique needs of students and their families. These classrooms are based on the principles of Applied Behavior Analysis (ABA), successful, research-based strategies that systematically teach behavior in a highly-structured environment, and all staff are trained in ABA strategies. To prevent more restrictive out-of-school placements, we offer educational aides to assist students in the program.

---

**Form 990, Part III, Line 4c:**

Treatment Foster Care & Adoption - LFSVA recruits and trains therapeutic foster parents so that children in foster care will have a stable, loving home environment while they are healing from the situation that caused the family disruption. We provide in-home services and emergency access to an agency social worker 24/7. Our goal is to help children move toward permanency. Because many of our families adopt the children they foster, we offer families the option to be certified as both foster and adoptive parents. Our in-depth training on parenting and support throughout the adoption process is considered one of the best such programs in the state. During the year ended June 30, 2017, we helped 53 children in foster care find homes in which to heal and grow. In addition to providing services to individuals and couples who wish to adopt from foster care, we also offer outpatient mental health services by an adoption-competent professional who understands the unique nature of building a family through adoption. In addition, our counselors provide Training for Adoption Competency (TAC) for mental health professionals to increase the number of adoption-competent mental health clinicians to serve adoptive families in Virginia. During the year ended June 30, 2017, 33 individuals received post-adoption counseling and 8 children found permanent, loving families through LFSVA.

Community-Based Services - (Expenses \$1,712,003, Revenues \$1,808,700) Therapeutic Day Treatment (TDT) helps children from kindergarten through 8th grade overcome the emotional and behavioral issues that create barriers to learning so they can participate more fully in the classroom and avoid unnecessary out-of-school placements. Highly-trained LFSVA staff works with students individually, in public school classrooms and in group settings at least one hour per day. This service is offered during the school year and through a four-week summer program. During the year ended June 30, 2017, we provided TDT services to 191 children.

The study process included a review of all job descriptions, a comparison of positions to market and the placement of all positions within LFSVA in pay grades. Concurrently, the Executive Committee of the Board of Directors worked directly with the consultant to complete a compensation study for the top five executive positions of the Organization. The report was sent directly to the Board of Directors for their review. LFSVA ensures that the compensation for each employee is at or above the minimum levels established through the study. LFSVA's goal is that compensation for all positions within the organization will be at the median levels established by the compensation study, as updated annually by the consultant.</p>
