

The majority of students are placed because they are functioning behind grade level and/or lack the social skills necessary to succeed in the public school setting.

Transition Training Services - Classroom-based activities include life skills instruction, career exploration and work-readiness training. Independent Living Skills and Career Assessments enable staff to identify areas that need to be addressed prior to a youth's transition. Counseling and instruction enable youth to then create a viable Career and Transition Plan.
