THIS IS AN ESPECIALLY IMPORTANT STEP GIVEN THAT 71% OF CLUB STAFF ARE PEOPLE OF COLOR AND 63% ARE WOMEN. BGCCVA CONTINUES TO WORK TOWARD LONG-TERM SUSTAINABILITY OF ITS NEW COMPENSATION MODEL, WHICH HAS REQUIRED A SIGNIFICANT FINANCIAL INVESTMENT BY THE ORGANIZATION. BY ALIGNING THE ORGANIZATION'S BUSINESS WITH ITS VALUES, THE CLUB IMPROVES PROGRAM QUALITY AND ELIMINATES BARRIERS TO ACHIEVEMENT EXPERIENCED BY ITS MEMBERS, STAFF, AND FAMILIES.
