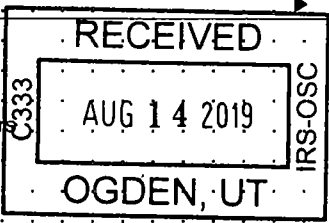



(1) A large quantity of merchandise for a sale is delivered to us during a five-day period preceding the sale. Although we occasionally provide receipts (without estimates of market value) upon request, we ordinarily do not have the time, expertise, or volunteer manpower available to do more than arrange and sell the merchandise. (2) This method would appear to be consistent with the purpose of the form, which is to document the monetary value of public support.
