THE ORGANIZATION ALSO SERVES PEOPLE BETWEEN JOBS, THOSE ON FIXED INCOMES, SENIORS, PEOPLE WITH DISABILITIES, AND HOMELESS CLIENTS. DURING 2015, THE NUMBER OF INDIVIDUALS FED INCREASED TO 63,000, 41,000 OF WHICH WERE CHILDREN. THIS AN INCREASE FROM 48,000 IN 2014 AND 35,000 IN 2013. DURING 2015, THE ORGANIZATION INCREASED STORE PICKUPS FROM THREE TO EIGHT EVERY DAY AND ADDED THREE PICKUPS ON SATURDAYS.
