The Ritchie County Educational Trust (RCET) makes low interest loans to Ritchie County residents pursuing post-secondary education. The RCET is a non-commercial revolving loan program for the express purpose of assisting worthy students in obtaining advanced education. Students who borrow money pay it back upon the completion of their studies at a low rate of interest, making that money available to other students in the future.

During 2016, loans were made totaling \$97,500. As of 12/31/2016, 154 individuals had loan balances totaling \$735,550. Of these, 46 were full-time students, and 108 were out of school paying on their loans. Of the total program service revenue listed above, \$16,407. came from loan interest. During the calendar year, a total of \$101,546. was received as principal payments on loans. In 2016, a total of 28 loanees paid off their loans, representing a principal total of \$107,150. being paid back. As of 12/31/2016, 1,379 loans have been repaid in full to the Ritchie County Educational Trust.
