The Ritchie County Educational Trust (RCET) makes low interest loans to Ritchie County residents pursuing post-secondary education. The RCET is a non-commercial revolving loan program for the express purpose of assisting worthy students in obtaining advanced education. Students who borrow money pay it back upon the completion of their studies at a low rate of interest, making that money available to other students in the future.

During 2017, loans were made totaling \$81,500. As of 12/31/2017, 148 individuals had loan balances totaling \$730,803. Of these, 44 were full-time students, and 104 were out of school paying on their loans. Of the total program service revenue listed above, \$15,684. came from loan interest. During the calendar year, a total of \$77,980. was received as principal payments on loans. In 2017, a total of 14 loanees paid off their loans, representing a principal total of \$96,300. being paid back. As of 12/31/2017, 1,393 loans have been repaid in full to the Ritchie County Educational Trust.
