The food is picked up daily and delivered at no cost on the same day to agencies that feed on-site. This program annually saves almost 6 million pounds of food. Almost 50 agencies in Mecklenburg and Iredell Counties are served by CFR. Distribution of Produce, Meat, Seafood, and Dairy SHFBM places a special emphasis on soliciting and distributing highly nutritious foods including produce, meats, dairy and seafood, needed for balanced and healthy diets. These are often the foods that people living in poverty can least afford. In 2016-2017 SHFBM distributed 21,408,819 pounds in these categories.
