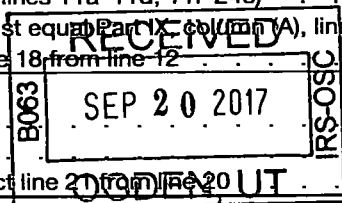

Part III, Line 4d: The DAV assists military veterans in many ways. Perhaps the largest way is by providing a local meeting place for retirees where they can come for recreation and for information about VA (Veterans Administration) programs and benefits. DAV Chapter 16 provides a meeting hall and a Chapter house to fulfill this purpose. Occupancy items (utilities, maintenance, etc.) associated with Veteran program services totalled \$ 25342 during the year covered by this tax return. Programs, events, assistance to needy veterans and newsletters/mailouts added another \$ 32,282 to service expenses. Asset depreciation associated with Veteran programs added a further \$ 10555. Other expenses (office, conferences and insurance) came to \$ 14133. Grand total for program services came to \$ 82312.

Part V, Lines 1 and 2: DAV Chapter 16 is an all volunteer organization. There is no paid staff.

Part VI, Line 11b: The treasurer, or other current year officer, reviews the form 990 with the accountant to see if there are any issues that need clarification. If so, the appropriate changes are made.
