Greensboro Housing Coalition is the advocate for fair, safe, and affordable housing. We help homeowners keep their homes by preventing foreclosure and promoting home maintenance. We help tenants resolve problems with their landlords, to prevent eviction and to get repairs so that their homes do not make them sick. We help people experiencing homelessness to move into apartments or houses that they can afford for the present and future. To resolve complex community problems such as substandard housing and homelessness we strengthen cooperation among a wide variety of nonprofit organizations, government agencies, and businesses. We raise community awareness of housing problems and solutions, promote public policies that expand broad housing opportunities, and participate in research studies to determine the best interventions for housing-related health risks and chronic homelessness. Our Housing Summit and healthy homes bus tour are two annual signature events that create new partnerships.

It encompasses our previous programs of Housing Search Assistance, Housing Hotline, and More Than Just a Mortgage to form a truly comprehensive service for households to gain--or avoid losing--decent housing. Housing Counseling also works cooperatively with a wide range of homeless services, landlords, realtors, lenders, and other organizations to promote affordable housing.
