Housing Through our two permanent supportive housing programs at Moore Place and through scattered site apartments, we ended chronic homelessness for 260 individuals last year. In addition to saving individuals by taking them off the street and placing them into housing, our programs save community resources. A chronically homeless individual costs the community an average of \$40,000 per year, while the same individual costs the community an average for \$14,000 per year when placed in permanent supportive housing.

SABER (Substance Abuse Treatment Program with Housing) Since 2006, 428 men have entered SABER with 84% successfully completing our three month program and 57% choosing to stay for six months of continuing care. Our completion rate is three times the national average and one-third of the cost. 92% of SABER clients who complete our nine-month program find employment before program completion.

Room in the Inn (Emergency Winter Shelter Program) Through our emergency winter shelter program, Room in the Inn, 16,834 nightly beds were provided to 1,427 men, women, and children at 150 different host sites around the greater Charlotte region. Host sites include congregations, schools, and community organizations. Medical services were offered by volunteer physicians and medical staff at various host sites to 343 of the individuals utilizing the program. An additional estimated 5,000 volunteers offered their time to help make our 2016 Room in the Inn program a success.
