HOUSING: THROUGH OUR TWO PERMANENT SUPPORTIVE HOUSING PROGRAMS AT MOORE PLACE AND THROUGH SCATTERED SITE APARTMENTS, WE ENDED CHRONIC HOMELESSNESS FOR 130 INDIVIDUALS FROM JANUARY-JUNE 2017. IN ADDITION TO SAVING INDIVIDUALS BY TAKING THEM OFF THE STREET AND PLACING THEM INTO HOUSING, OUR PROGRAMS SAVE COMMUNITY RESOURCES. A CHRONICALLY HOMELESS INDIVIDUAL COSTS THE COMMUNITY AN AVERAGE OF \$40,000 PER YEAR, WHILE THE SAME INDIVIDUAL COSTS THE COMMUNITY AN AVERAGE FOR \$14,000 PER YEAR WHEN PLACED IN PERMANENT SUPPORTIVE HOUSING.

NEIGHBOR SERVICES: URBAN MINISTRY PROVIDES BASIC SERVICES FOR ANYONE IN NEED. IT'S OUR WAY OF AFFIRMING THE DIGNITY OF EACH HOMELESS NEIGHBOR WHO MAY NEED A HOT SHOWER, CLEAN CLOTHES, A PHONE CALL OR MESSAGE FROM FAMILY AND THE SUPPORT NEEDED TO TAKE THE NEXT STEP OUT OF HOMELESSNESS. THESE SERVICES PROVIDE ADDITIONAL OPPORTUNITIES FOR HOMELESS INDIVIDUALS TO CONNECT WITH CARING VOLUNTEERS AND STAFF, ENABLING FURTHER CONTACT WITH THE CONTINUUM OF CARE AND SERVICES IN CHARLOTTE.
