SCATTERED-SITE APARTMENTS - THROUGH THIS PERMANENT SUPPORTIVE HOUSING PROGRAM, ROOF ABOVE CONNECTS CHRONICALLY HOMELESS INDIVIDUALS WITH A RENT SUBSIDY, WHICH IS USED ON THE PRIVATE MARKET. THE ROOF ABOVE SCATTERED-SITE TEAM PROVIDES SUPPORTIVE SERVICES WITHIN THE HOME OF TENANTS IN THIS PROGRAM.SUBSTANCE ABUSE TREATMENT PROGRAM WITH HOUSING ("SABER") - THE SABER TREATMENT PROGRAM COMBINES INTENSIVE GROUP AND INDIVIDUAL THERAPY WITH SUPPORTIVE HOUSING. THE COMPLETION RATE OF SABER IS THREE TIMES THE NATIONAL AVERAGE AND ONE THIRD OF THE COST.
