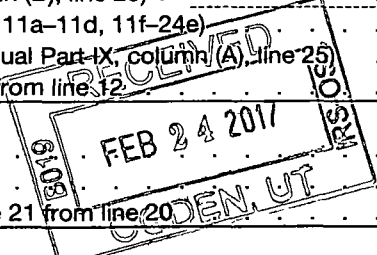

**NC Pre-Kindergarten-Offers a high quality pre-kindergarten classroom experience to eligible four year old children. 431 children were served through this program.**

**Family Support-Programs support parents of young children during this critical period of child development by educating them about developmentally appropriate strategies for effective discipline and the promotion and teaching of effective literacy practices. 176 families and 233 children received home visits through the Parents as Teachers program, with parents attending 14 group sessions. 80% of families who received needs-based referrals completed the referral process. 104 parents were served through the Incredible Years program, affecting 127 children. Over 60% of parents completed at least 75% of sessions. 3 medical practices participated in Reach Out and Read with 489 new children added to the program. 1244 children were served. 2101 new children were added to Dolly Parton's Imagination Library and 2819 children were served.**

**Child Care and Education Quality-Programs help early education and child care facilities reach and maintain the highest possible quality of services for young children; Help families access and afford child enrollment in high quality early education sites and help early educators improve their education and wages. 22 sites received technical assistance to either improve or maintain star rating through the Child Care Resource and Referral program and 336 teaching staff participated in trainings. Child Care enrollment subsidies provided funding for 927 monthly subsidies for working families and parents in school, with priority given to children with special needs. The WAGES and Professional Development programs provided salary supplements for 140 early care and education professionals from 47 child care sites at least once during the year. Through this program, 79 early care and education professionals attended summer classes at Alamance Community College and 78 checked out college level textbooks. Outdoor Learning Environment (OLE) provided training for 112 early care and education professionals and 49 parents.**
