NC Pre-Kindergarten-Offers a high quality pre-kindergarten classroom experience to eligible four year old children. 426 children were served in NC Pre-K classrooms in Alamance County.

**4b** (Code: ) (Expenses \$ 589782 including grants of \$ 94907) (Revenue \$ 0)  
Family Support-Programs support parents of young children during this critical period of child development by educating them about developmentally appropriate strategies for effective discipline and the promotion and teaching of effective literacy practices. The Parents as Teachers program provided for home visits to 163 families and 220 children with 91% of children ages 3-5 scoring at or above developmental expectations following program participation. Parents attended 13 group sessions. 3 medical practices participated in the Reach Out and Read program with 500 new children being added and 1582 children served. 1937 new children were added to Dolly Parton's Imagination Library and 3780 children were served. Through the Incredible Years program, 128 parents were served, affecting 169 children and over 60% of parents completed at least 75% of sessions. The following community events were provided to the public or participated in by the Partnership: Roll and Read, Active City Streets, Burlington Holiday Parade, Carousel Festival, Eastlawn Baptist Trunk or Treat, Healthy Kids Day in the Park, Dickens Downtown Christmas, Project Homeless Connect, Burlington Royals Easter Egg Hunt. On April 25, 2017, the Partnership hosted its annual Early Education Summit and created a forum to discuss the importance of outdoor play and the growing issue of "nature deficit" in children. More than 110 attendees gathered to hear the keynote speaker, Robin Rogers, co-founder of Cedarsong Nature School in Washington State.

Child Care and Education Quality-Programs help early education and child care facilities reach and maintain the highest possible quality of services for young children; Help families access and afford child enrollment in high quality early education sites and help early educators improve their education and wages. 28 sites received technical assistance to either improve or maintain star licensure ratings and 342 teaching staff participated in trainings through the Child Care Resource and Referral program. The Outdoor Learning Environment (OLE) provided opportunity for 46 early care and education professionals to participate in trainings and 47 early childhood professionals used the Outdoor Learning Environment for field trips and outings. In addition, an outdoor playgroup program was initiated for parents. Through a State Contract, funds were provided for WAGE\$ Salary Supplements for 135 early care and education professionals from 50 child care sites at least once during the year. 68 early care and education professionals checked out college level textbooks through this program.

The Kaleidoscope Play and Learn program was added. A part-time early learning coordinator facilitated Kaleidoscope Play and Learn groups for children birth through five and their caregivers not enrolled in full-time regulated childcare. The play groups were held once a week at various accessible locations throughout Alamance County and met for at least 90 minutes. Hands-on activities included developmentally appropriate materials, books and learning games to focus on early-literacy skills. Services included activities that are developmentally and age appropriate and demonstrate vital aspects of a high quality early childhood experience and appropriate teaching, modeling and learning through play concepts. Caregivers learned what to expect from their children as they learn through play while having the opportunity to meet other parents. Using the Kaleidoscope Curriculum, caregivers participated in open-ended, child-directed play that supports the different areas of development (e.g., cognitive, social-emotional, language, fine-gross motor, etc.). Children and caregivers participated in coordinated group activities and received educational materials and program incentives.
