NC Pre-Kinderqarten-Offers a high quality pre-kinderqarten classroom experience to eligible four year old children.

Family Support-Programs support parents of young chidren during this critical period of child development by educating them about developmentally appropriate strategies for effective discipline and the promotion and teaching of effective literacy practices. Kaleidoscope provided 33 sessions of facilitated playgroups to 23 parents/caregivers and 29 children. Parents as Teachers program provided 1409 home visits and 13 group meetings to 153 families. 202 children were also served. Through the Incredible Years program, 40 parents/guardians of children ages 3-5 were served, representing 42 children, and 47 parents/guardians of children ages 6-12 were served, representing 61 children. Incredible Years Autism served 13 parents/guardians representing 17 children. Dolly Parton's Imagination Library provided books to 5895 children with 2510 new children added this year. 2068 children participated In Reach Out and Read with 488 new children added to the program. Through its Community Outreach program, the Partnership hosted, sponsored or participated in 23 events. 5 newspaper articles about the organization were published with 127 new Facebook "likes".

Child Care and Education Quality-Programs help early education and child care facilities reach and maintain the highest possible quality of services for young children; Help families access and afford child enrollment in high quality early education sites and help early educators improve their education and wages. 342 teaching staff received technical assistance to either improve or maintain star licensure ratings through 24 trainings facilitated by the regional Child Care Resource and Referral Agency. The Outdoor Learning Environment (OLE) provided access to a high-quality learning environment for 8 childcare professionals and 48 play groups participated during the year. In addition, 3 OLEs were created at NC Pre-Kinderqarten sites. 67 college-level textbooks were checked out by 26 childcare professionals representing 23 sites through the Professional Development program. Through a State Contract, funds were provided for WAGE\$ Salary Supplements for 149 early care and education professionals from 47 child care facilities at least once during the year.
