Other early educators seeking to enhance their instructional practices may also request delivery services, when transportation is a barrier. Members may be provided with nominal resources (ex activity kits, books) through non-cash grants to enhance and extend knowledge gained from participating in trainings of the Lending Library. New members will receive an orientation to the Lending Library, which may be open for use some nights and weekends to increase access. The Lending Library Coordinator may participate in events such as Week of the Young Child and other events as determined relevant by the partnerships Executive Director. At a minimum, the Coordinator of the Resource and Lending Library will hold an Associate Degree.
