NC Pre-Kindergarten-71 four-year olds at risk of failure in kindergarten received quality pre-kindergarten services in order to enhance kindergarten readiness skills. Parents of pre-school children and Pre-K programs were provided with resources, materials and skill-building strategies for parents to implement at home to help support the development of their children's kindergarten readiness skills. 175 children were served.

4b (Code: _____) (Expenses \$ 83412 including grants of \$ 62625) (Revenue \$ 0)
Childcare and Education Quality-22 child care staff attended non-credit based training or workshops through the Child Care Resource and Referral program. 49 adults utilized the Resource Lending Library including 20 child care providers from 3 child care centers. Educational materials were provided to 24 children and 3 early childhood classrooms at 1 child care center to promote and increase participation in the 2019 Month of the Young Child. These activities focus public attention on the needs of young children and their families and recognize the early childhood programs and services that meet those needs. Each of the 24 children received 1 book and the 3 classrooms at 1 child care center each received 3 books. Professional Development Incentives were awarded to 19 child care providers, working in 7 child care centers. 3 of these providers from 2 child care facilities earned early childhood education credits. The incentive awards encourage child care providers' pursuit of higher education, through increased compensation and supporting employment longevity.

Family Support-61 children participated in the Raising a Reader program. 4 classrooms at 3 child care centers served as sites. 18 parent literacy workshops were provided with 85 parents participating in at least one workshop. To increase the number of books in children's homes, 64 children were provided with books to build their home library and a blue library bag. Each of the children received 13 books and 1 book bag. 5 parents received a \$25 gift card for completing a parent literacy workshop, which is designed to help parents develop, practice and maintain home-based literacy habits and 1 parent received a \$50 gift card for completing a parent literacy workshop. 2 medical clinics participated in the Reach Out and Read program and distributed 444 developmentally appropriate new children's books during well child visits. Additional developmentally appropriate books were purchased for these clinics to disburse following the distribution of donated books from other sources. Dolly Parton's Imagination Library mailed 3,919 books to 496 participating children. Incentive books were also mailed to 46 children to encourage enrollment in the program.
