Medical Clinic Project Special Appropriations Grant between the State of North Carolina, Department of Health and Human Services, Division of Public Health and Carolina Pregnancy Care Fellowship NCDHHS provided funding to Carolina Pregnancy Care Fellowship, aka as CPCF, to purchase durable medical equipment for clinics and provide training to pregnancy center clinics on the use of the durable equipment (ultrasound machines) NCDHHS also provided funds for the Human Coalition to develop and implement a two-year continuum of care pilot program at its Raleigh Clinic. The 2 year plan was changed to 1 year of which in 2018 funds were provided for the last 2 quarters of year one. The pilot program provided care coordination and medical support to women experiencing crisis pregnancies. In 2018 19 ultrasound machines were purchased, installed and delivered to various pregnancy centers in NC at the cost of \$550,276. Other various medical durable equipment such as exam tables, probe caddys, and mobile stands were purchased and delivered to 14 pregnancy centers at the cost of \$25,084. As per the Special Appropriations grant provisions allowed for fund to be used for ultrasound training. 22 pregnancy centers hosted trainings in 2018 at the cost of \$109,287. Several trainings were comprised of attending nurses from several pregnancy centers from North Carolina. \$150,000 was used for Human Coalitions pilot program. \$18,300.00 was used for administrative costs that include personnel, travel, supplies, postage and Federal Express, as well as phone, Internet and required audit fees.

Form 990, Part III, Line 4b:

Maternal Health Grant, a block grant between the State of North Carolina, Department of Health and Human Services, a Division of Public Health and Carolina Pregnancy Care Fellowship. In 2018 there were 34 pregnancy centers that participated in the grants. There were 2 fiscal year contractual grants that were in place for 2018, as each new year began in June. Each pregnancy center submitted a budget that was approved by NCDHHS. Pregnancy centers purchased items based on their approved budget. Items or services varied between pregnancy centers based on the account line used in their budget. Example of items purchased were maternal health client related curriculum, staff development events, various training costs, advertising, medical clinic and office supplies and materials, IT and office equipment, incentives for clients such as baby clothing, baby furniture or equipment, diapers and many other baby items. The Maternal Health Grant reimbursed CPCF for administrative costs as well as pregnancy center purchases.
