WHAT BEGAN IN A SMALL COMMUNITY CENTER SERVING LESS THAN 50 KIDS PER DAY SOME 15 YEARS AGO HAS GROWN INTO A SERVICE THAT OVER 400 HOUSEHOLDS RELY ON IN OUR COMMUNITY THE CINDY PLATT BOYS & GIRLS CLUB OF TRANSYLVANIA COUNTY SERVED OVER 200 YOUTH EACH DAY IN 2015 THROUGH OUR AFTERSCHOOL AND SUMMER PROGRAMS IN OUR 25,000 SQUARE-FOOT FACILITY FOUNDED IN 1999 BY THE LATE CINDY PLATT, THE CINDY PLATT BOYS & GIRLS CLUB OF TRANSYLVANIA COUNTY IS COMMITTED TO ENABLING ALL YOUNG PEOPLE, ESPECIALLY THOSE WHO NEED US MOST, TO REACH THEIR FULL POTENTIAL AS PRODUCTIVE, CARING, RESPONSIBLE CITIZENS WE ARE A DEVELOPMENTAL ORGANIZATION SERVING SCHOOL-AGED YOUTH, AGES 5 TO 18 YEARS OLD WE IMPLEMENT AFTER-SCHOOL AND SUMMER PROGRAMS THAT FOCUS ON FIVE CORE PROGRAM AREAS CHARACTER AND LEADERSHIP DEVELOPMENT, EDUCATION AND CAREER DEVELOPMENT, HEALTH AND LIFE SKILLS, THE ARTS, AND SPORTS, FITNESS AND RECREATION AS THE LARGEST YOUTH DEVELOPMENT ORGANIZATION IN THE COUNTY, OUR CLUB EXPERIENCED RECORD GROWTH IN 2015 THE FOLLOWING SAMPLING OF DATA FROM 2015 SHOWS NOT ONLY THE PROGRESS WE HAVE MADE, BUT THE IMPACT WE ARE MAKING THROUGH OUR PROGRAMS, STAFF AND VOLUNTEERS - WE SERVED 659 SCHOOL AGED YOUTH, 41% MORE THAN WE SERVED IN 2014 OF THOSE SERVED, 11% WERE REACHED THROUGH PROGRAMS THAT ARE AVAILABLE TO NON-CLUB MEMBERS SUCH AS JAM AND SMART GIRLS & BOYS - OUR TEEN MEMBERSHIP GREW BY 34% AND WE SERVED 414 HOUSEHOLDS, 18% MORE THAN 2014 - 84% OF OUR MEMBERS HAVE BEEN WITH US MORE THAN 2 YEARS, A 36% INCREASE IN RETENTION FROM 2014 - OUR AVERAGE DAILY ATTENDANCE OF 215 MEMBERS IS A 31% INCREASE FROM 2014 - EACH MONTH, WE SERVED AT LEAST 75% OF OUR TOTAL MEMBERSHIP, A RECORD FOR US THIS COMMUNICATES THAT OUR MEMBERS ARE COMING MORE OFTEN - WE SERVED 11,602 MEALS, 29,627 SNACKS AND HARVESTED 2,800 POUNDS OF PRODUCE FROM OUR GARDEN, MOST OF WHICH WAS GIVEN DIRECTLY TO OUR CLUB FAMILIES - OVER A THIRD OF THE MENTEES IN OUR MENTOR PROGRAM SHOWED IMPROVEMENT IN AT LEAST ONE TARGETED BEHAVIOR (ANTISOCIAL BEHAVIOR, FAMILY RELATIONSHIPS, OR SOCIAL COMPETENCE) SINCE ENTERING THE MENTORING PROGRAM IN 2015 - WITHIN OUR EDUCATION PROGRAM, FROM SPRING 2015 TO FALL 2015, WE INCREASED THE NUMBER OF REPORT CARD CONSENT FORMS FROM CLUB FAMILIES BY 26% THESE CONSENT FORMS ALLOW US TO RETRIEVE OUR MEMBERS' REPORT CARDS TO ANALYZE THEIR EDUCATIONAL NEEDS FROM SPRING 2015 TO FALL 2015, WE SAW A 98% INCREASE IN MEMBERS WHO ACHIEVED HONOR ROLL, A 14% INCREASE IN THE NUMBER OF MEMBERS WHO INCREASED THEIR GRADES AND A 25% DECREASE IN THE NUMBER OF MEMBERS WHO HAD C'S, D'S, AND F'S LASTLY, FROM FALL 2015 TO SPRING 2016, 8% MORE MEMBERS HAD HONOR ROLL AND WE SAW A 104% INCREASE IN THE NUMBER OF MEMBERS WHO INCREASED THEIR GRADES PROGRAM OVERVIEW OUR CLUB'S AFTERSCHOOL AND SUMMER PROGRAMS ADDRESS THE CHALLENGES OF AFFORDABLE YOUTH DEVELOPMENT PROGRAMS AND ACCESS TO TRANSPORTATION BY OFFERING OUR PROGRAMS FOR A LOW MEMBERSHIP FEE OF 50 PER CHILD FOR THE SCHOOL YEAR AND 150+ PER CHILD FOR OUR 8-WEEK SUMMER PROGRAM, WE ARE POSITIONED TO SERVE ALL YOUTH REGARDLESS OF THEIR SOCIO-ECONOMIC STATUS SCHOLARSHIPS ARE ALSO AVAILABLE FOR FAMILIES THAT ARE UNABLE TO PAY THE MEMBERSHIP AND PROGRAM FEES TO FURTHER SUPPORT OUR CLUB FAMILIES, WE PROVIDE TRANSPORTATION TO THE CLUB FROM 8 OF THE 10 SCHOOLS IN THE COUNTY, EXTEND OUR WEEKDAY HOURS DURING THE SCHOOL YEAR TO 7PM AND OFFER EARLY DROP OFF AT 7 30AM DURING OUR SUMMER PROGRAM WE ALSO PROVIDE SNACK AND DINNER FOR YOUTH DURING THE SCHOOL YEAR AND BREAKFAST AND LUNCH DURING OUR SUMMER PROGRAM OVER 50 YOUTH HAVE A HOT DINNER WITH US EVERY NIGHT DURING THE SCHOOL YEAR BEFORE THEY GO HOME OUR EFFORTS IN PROVIDING QUALITY, ENRICHING PROGRAMS ARE CENTERED AROUND THE FIVE ELEMENTS OF POSITIVE YOUTH DEVELOPMENT WE PROVIDE A SAFE, POSITIVE AND FUN ENVIRONMENT, HELP OUR MEMBERS DEVELOP SUPPORTIVE RELATIONSHIPS WITH STAFF, PEERS, FAMILY, ETC , PROVIDE OPPORTUNITIES FOR GROWTH AND TEACH MEMBERS ABOUT EXPECTATIONS AND ACCOUNTABILITY, WHILE ALSO RECOGNIZING AND REWARDING THEIR EFFORTS AND GROWTH THROUGH OUR EDUCATION PROGRAM, WE ADDRESS THE UNIQUE NEEDS OF OUR MEMBERS BY PROVIDING PROGRAMS AND RESOURCES TO COMPLIMENT WHAT THEY ARE LEARNING IN SCHOOL IN ADDITION TO POWER HOUR, (STRUCTURED TIME FOR STAFF AND VOLUNTEERS TO ASSIST MEMBERS WITH THEIR HOMEWORK), WE ALSO HELP MEMBERS BUILD ESSENTIAL FOUNDATIONAL SKILLS THROUGH OUR HOMEWORK CLUB DURING THE SUMMER, WE PROVIDE AN EDUCATIONAL PROGRAM THAT INTEGRATES MATH, SCIENCE, LANGUAGE ARTS AND HISTORY WITH PHYSICAL ACTIVITY TO KEEP THE CHILD'S MIND ACTIVE AND ENGAGED OUR HEALTH & LIFE SKILLS FOCUS AREA INCLUDES FOUR VERY POPULAR PROGRAMS - HEALTHY HABITS, HARVEST PROJECT, TRIPLE PLAY AND SMART GIRLS & BOYS THESE PROGRAMS PROMOTE HEALTHY LIFESTYLES THROUGH HEALTH AND FOOD SYSTEMS EDUCATION, PHYSICAL ACTIVITY AND YOUTH EMPOWERMENT MEMBERS LEARN HOW TO COOK HEALTHY FOODS USING PRODUCE FROM OUR GARDEN THAT THEY PLANTED, NURTURED AND HARVESTED ON A DAILY BASIS, CLUB MEMBERS ENGAGE IN A MINIMUM OF 30 MINUTES OF PHYSICAL ACTIVITY THROUGH OUR TRIPLE PLAY PROGRAM OUR SMART GIRLS & BOYS PROGRAM, WHICH MEETS WEEKLY FOR THE SCHOOL YEAR, RAISES AWARENESS OF HEALTHY EATING AND LIFESTYLES, AND EQUIPS MEMBERS WITH THE TOOLS TO HANDLE CONFLICT AND DIFFICULT CHOICES WHILE ALSO PREPARING THE MEMBERS FOR COMPETING IN A LOCAL 5K RACE ALSO INCLUDED IN OUR HEALTH & LIFE SKILLS PROGRAMS ARE SMART MOVES AND STREET SMART, BOTH SHORT-TERM PROGRAMS SMART MOVES HELPS MEMBERS DEVELOP POSITIVE DECISION MAKING AND CRITICAL THINKING SKILLS WHILE ALSO LEARNING HOW TO AVOID AND/OR RESIST ALCOHOL, TOBACCO, OTHER DRUGS AND PREMATURE SEXUAL ACTIVITY STREET SMART TEACHES YOUTH, AGES 10-14, ABOUT GANG AND VIOLENCE PREVENTION WHILE NURTURING RESILIENCY SKILLS AND COVERING BULLYING PREVENTION SOME OF OUR EXTRACURRICULAR PROGRAMS FOR ALL AGES INCLUDE A MENTORSHIP PROGRAM, INSTRUCTIONAL ATHLETIC CAMPS THROUGH A COLLABORATION WITH BREVARD COLLEGE, A LITERACY PROGRAM PROVIDED BY PURE PETS IN WHICH MEMBERS READ TO DOGS, AND JAM -
