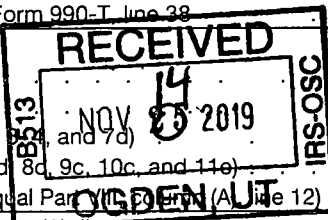

Key Career Retention and Career Advancement Programs to promote and sustain the economic well being of clients include Professional Women's Group Program (PWG). Operated as a Professional Organization, the PWG strives to teach underserved women about workforce communication, corporate culture, financial literacy and wealth building, advancement of career skills, work/life balance and more. There were 60 active members in 2018

The Professional Women's Group (PWG) had 60 members in 2018 and 94% retained employment and 40% received a salary increase. The PWG industry standard is 75%. The PWG is a free professional monthly membership offered to clients upon securing employment. Salaries for PWG members range from \$14,560 - \$50,000 and hourly rates range from minimum wage to \$24.00 per hour

4b (Code) (Expenses \$ 306,448 including grants of \$ 0) (Revenue \$ 0)
Interview and Employment Suiting Program. As part of the organization's job preparedness and job acquisition services, clients are educated on what is appropriate for professional interviews and upon receiving a job, what meets their workplace dress code. Clients will receive up to two complete outfits for the interview, and up to five more outfits once they obtain employment. Distribution of inventory may vary depending on size and availability. Of the 760 clients referred to these programs from 71 Referral Agency Partners, 640 received interview and/or employment suiting apparel and accessories. The income and expenses for this program are all non-cash donations

4c (Code) (Expenses \$ 55,000 including grants of \$ 0) (Revenue \$ 0)
Career Center. In 2018, 233 (unduplicated and voluntary sign-in) clients utilized the Career Center for a total of 459 visits. There were 369 appointments to access professional HR services. 100% of unduplicated clients reported securing at least one interview. Also in 2018, the Career Center expanded by more than 200% with the purchase of new laptops. Computer training classes expanded with workshops on Intro to MS Office, Beginner and Advanced Word, and Beginner and Advanced Excel in small classroom settings of up to 6 people or up to 25 in our Community Room. 108 clients enrolled in these classes. Additional professional development workshops, including "Are you Job Ready?" and "Resume 101" are offered by professional Human Resources partners and held throughout the year

The mission of Dress for Success is to empower women to achieve economic independence by providing a network of support, professional attire, and the development tools to help women thrive in work and in life

Financial Education Designed as a response to the need of our women for financial education. The curriculum was developed with national endowment for financial education and provides education on such topics as basic banking, budgeting, credit management, debt, investment, retirement, taxes, workplace benefits and the government and your money

70% of participants did not have financial goals upon entry and 100% had a plan at the conclusion of the program with 90% reporting they were sticking to the plan 30% of participants did not know their credit scores upon entry 100% established an emergency fund which was up from 20% upon entry. These emergency funds held an average of \$1,445 at the conclusion of the program. Money held in checking accounts grew, on average, from \$714 to \$1,028 and savings from \$364 to \$1,685

Going Places Network (GPN) Helps unemployed and under-employed clients gain career skills, learn how to utilize job search resources, and build confidence. In 2018, 37 women participated in the GPN and 100% completed the program with 51% securing employment within 30 days of program completion and 65% at 90 days post program

Professional Development Workshops Various workforce development topics such as "Are you job ready?" and "Interviewing 101" are offered by various HR partners

Organizational Impact In addition to impact reported by individual program, overall, data collected from all internal programs, and partner agencies, tells us that 68% of those receiving Dress for Success Charlotte services are securing employment
