This agency operates a store selling donated items to the public with the proceeds going to charitable projects. In calendar year 2017 - 5 cancer patients received help for transportation, special foods and treatments at a cost of 10,000, the local crisis pregnancy center received 2,000 for supplies and family members with serious medical conditions received 5,000 for travel expenses and other cost. There were numerous request from families in Richmond County for wheel chair ramps. 3,312 was donated to Pine Grove Baptist church to build 10 wheelchair ramps, The First Baptist and Second Baptist churches received 4,503 to build 9 wheelchair ramps and an individual contractor received 3,723 to install 7 wheelchair ramps. Also in 2017 The Chrstian Closet provided 2,000 to a family to help purchase a wheelchair for their daughter, 2,000 was given to the county high school to provide 2 scholarships and The Richmond County Community College Foundation received 1,000 for its scholarship fund

School uniforms were purchased costing 7,122 for children from low income families and 1,024 was donated to the Richmond county schools to provide very young students with undergarments. Also in 2017 a donation of 500 was made to Toys for Tots, a vehicle repair for an individual with medical needs was completed for 658, a father and his three children received 2,000 in December for help with clothing, bills and Christmas items and a donation for 3,000 was made to the back pack program to provide children with after school and weekend meals. Other items during the year 599 donated to the Red Cross and DSS for clothing and shoes and the Presbyterian Church received 500 to purchase shoes for underprivileged children. Note included in this program cost is 245,209 for salaries, building operating cost and overhead to fund this organization's mission.
