This agency operates a store selling donated items to the public with the proceeds going to charitable projects. In calendar year 2019 - The local crisis pregnancy center received 3,000 for supplies and the Samarton Colony Womens Center received 2,000 for operations. There were numerous request from families in Richmond County for wheel chair ramps 3,245 was donated to Pine Grove Baptist church to build 10 wheelchair ramps, Hamlet Second Baptist received 8,190 to provide 23 ramps, Cobb Baptist received 430 to build a wheelchair ramp and Pee Dee Baptist received 2,931 for 4 ramps. An individual contractor received 9,668 to install 18 wheelchair ramps. Also in 2019 The Christian Closet provided 6,000 to 3 families to help with living expenses and medical cost, 2,000 was given to the county high school to provide 2 scholarships and The Richmond County Community College Foundation received 1,000 for its scholarship fund

School uniforms were purchased costing 6,297 for children from low income families and 4,700 was donated to help 3 families with living expanses. Also in 2019 a donation of 500 was made to Toys for Tots, a 100 donation to Pine Grove Baptist Church and provided 1,500 for a student to attend a National Youth Leadership Forum. A 500 purchase to provide shoes for underprivlaged children, a family received 2,500 to repair their heating system and the Friends of the Hamlet Public Library received 2,000 for the SRP/Story time program. Another item during the year an inkind donation of clothing and shoes valued at 574 was given to the Red Cross and people with special needs. Note included in this program cost is 281,925 for salaries to operate the store, building operating cost and overhead to fund this organization's mission

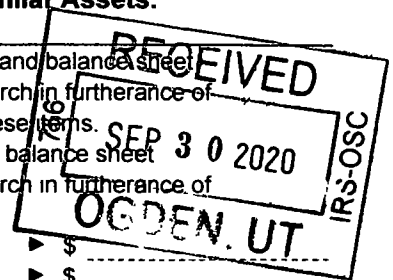

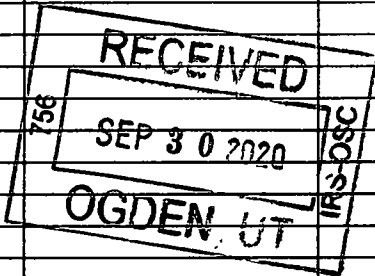
