 Abuse Later in Life/Elder Abuse liveSAFE Resources operates the Abuse in Later Life program to specifically address the issue of elder abuse in our community This includes organizing multi-disciplinary team meetings to discuss ways to improve system response and collaboration as well as delivery of direct services to victims of domestic violence, sexual assault, and stalking who are 50+ years of age The Abuse in Later Life Coordinator is a dedicated victim advocate who conducts telephone outreach to victims from incident reports given to her by the Cobb County Police Department's Special Victims Unit Cases are also referred to the program from other police departments, Adult Protective Services, the liveSAFE Resources Legal Advocacy Office, Cobb Senior Services and other community agencies The Abuse in Later Life Coordinator provides a variety of services including accompaniment to medical and legal appointments, assistance applying for benefits and Crime Victims Compensation, safety planning, assistance in accessing safe shelter, which may mean coordinating entry into a licensed personal care home or nursing facility, help navigating the criminal justice system and applying for Temporary Protective Orders, financial assistance Financial assistance may be provided to assist with the cost of medications, housing, utilities, and transportation for clients of the Abuse in Later Life Program as elder abuse often involves financial exploitation and often leaves victims without the funds to meet their basic needs In the last year, the Abuse in Later Life Program served 123 victims

Transitional Housing Transitional housing is offered up to 24 months for qualified victims of domestic violence. The program has twelve apartments and three houses as well as programs to assist victims to remain in housing in the community. The focus is on economic empowerment to move clients, whether with children or without, toward sustainability for living independently in permanent housing free of violence. The program serves women and children fleeing a domestic violence situation. They can self refer or be referred by a liveSAFE Resources, Inc. case manager or an outside agency. Eligibility for admittance into the transitional housing program is a specific criterion that identifies them as a victim of domestic violence who does not want to return to an abusive relationship and is making steps to become self-sufficient. Through an extensive network of service providers and community partners and volunteers, we help women, children and families reclaim their lives. During the year ended 6/30/2017, over 70 clients lived in liveSAFE Resources, Inc. transitional housing.
