The mission of the United Way of Colquitt County, Inc is to organize, coordinate, and maximize the resources available to our diverse community and to improve the quality of life In 2015, the United Way of Colquitt County, Inc provided over \$368,200 in grants to 24 Human Service agencies by funding 35 programs serving more than 12,000 individuals in Colquitt County Annually, the United Way provides assistance and funding to make possible the Dictionary Project which provides a student dictionary to every 3rd grader in Colquitt County Day of Action was held September 23, 2015 where more than 70 volunteers worked at 8 agencies on projects of need Children's Toy Shop, Colquitt County Arts Center, Hero House, Moultrie YMCA, Moultrie/Colquitt Library, Odom Elementary, and the Boys and Girls Clubs of Moultrie/Colquitt County all had teams of volunteers working and a wheelchair ramp was built for a family in need Community Impact Grant funding continued with the Colquitt County Board of Education to assist with the needs of homeless students in conjunction with the McKinney Vento Homeless grant This award assists to fill in the gaps for students faced with poverty, hunger, illness, and other barriers to success in school and life The Colquitt Regional YoVo Program funding also continues to serve local youth to provide workforce readiness skills in the area of healthcare A Community Impact grant was also awarded to the Moultrie/Colquitt County Library in the fall of 2015 to provide funding for Story Time in the Parks This provides interactive story times through puppetry, role playing, mime, etc in order to take the library out to the community and to promote the parks as community hubs In 2015, the United Way also contracted with Amanda Beaty as a grant writer to work for local agencies in securing new funding sources through grants in order to help them achieve their goals for the community
