More than 1000 hours were given by volunteers for these projects. The United Way continues to fund four three year community impact grants that were awarded in 2017 and 2018: Family Connection's Colquitt County Baby Book, Colquitt Regional Medical Center's Health Occupation and Math Enrichment Program, Colquitt County Art Center's ABC Grant, Southwest Georgia Community Action Council's Summer Expansion Program(Yes!) Funding for these projects totaled \$25,150 for 2019.
