EXCLUDING A SPECIAL SUPPORTER EVENT, 80% OF EVERY DOLLAR RECEIVED SUPPORTS PROGRAMS AND SERVICES. CCA ENSURES THAT VULNERABLE INDIVIDUALS CAN ATTAIN ECONOMIC SELF-SUFFICIENCY THROUGH PROGRAMS DESIGNED TO A) DEVELOP CRITICAL LIFE SKILLS, B) PROVIDE EDUCATION AND ACCESS TO EMPLOYMENT, AND C) ADDRESS THEIR WELL-BEING AND ENSURE FAMILIES HAVE BASIC FOOD SECURITY AND SAFETY.
