Our experiences have encouraged us to plan for the continued use of recorded content for use in conjunction with partner-based programs as well as increased learning content for girls working individually or who missed sessions. Girls Inc. coordinated with the school systems to offer full day programming in the early fall (complying with COVID19 requirements) in order to offer an alternative to home schooling for girls whose parents were working. Most recently, Girls Inc. has returned to providing after-school and partner-based programming (not all-day programming), including an in-person after-school program, virtual after-school/partner-based programming. Girls Inc. added components of new programming this year, including a weekend STEM Club with girls from Clayton, Cobb, Fulton, and Douglas Counties currently meeting virtually and a comprehensive wellness program that includes physical, mental, and emotional health strategies, a personal wellness plan, and an outlet for sharing in a safe space. Because of the Pandemic this summer, our summer camp programming was modified significantly in content, time, and ability to provide field trips, job shadowing, and person to person mentoring. May: Girls Inc. provided fun challenges and activities ("Girls Inc. On-The-Go") via our social media platforms and emails. June: Girls Inc facilitated virtual programs for 30 elementary and middle school girls via Zoom. July: The center opened for on-site Summer University from July 6th 17th for 23 elementary and middle school girls.</p>
