4a (Code) (Expenses \$ 662,079 including grants of \$) (Revenue \$) Crisis intervention services involves all services that strive to address the critical time in the aftermath of victimization or the reporting of the crime. The 24-hr crisis lines (English & Spanish) serve as the gateway to all of DCRC's services. Callers can receive emotional support, information, safety planning and referrals. They can be connected with other services such as counseling and assessed for emergency shelter. In the current year, the crisis line responded to a approximately 5,700 calls. Some 210 victims of sexual assault or domestic violence were met at area hospitals for support during forensic examinations and medical services. Overall, the agency assisted 292 persons for sexual assault related crimes and 1,536 for domestic violence. DCRC hosted 921 individual sessions and 94 group sessions that were guided by staff and student interns.

4b (Code) (Expenses \$ 514,252 including grants of \$) (Revenue \$ 1,950) Legal advocacy continues to be an integral part of DCRC's programming. In the prior year, we opened the Durham Family Justice Center, a "one-stop shop" concept whereby victims are able to receive a variety of services in one location. Located in the courthouse, victims receive support as they work through the criminal and civil justice systems. Advocates and volunteers assist them with reporting to law enforcement, offer court accompaniment, case management, filing protective orders, filing for victim compensation, and other services. Bilingual services are also a part of this component. In the current year, DCRC assisted in 1,567 cases and helped redefine policies & procedures. DCRC continues to commemorate Domestic Violence & Sexual Assault Months and other outreach and awareness programming.

4c (Code) (Expenses \$ 275,059 including grants of \$) (Revenue \$) DCRC operates a temporary emergency shelter offering women and children who are fleeing violent homes a safe and supportive environment. In the current year, 225 women and children were provided shelter. We were unable to shelter 140 others whose circumstances made them eligible for services because we lacked the space. This number reflects only adults; not the children who might have come with them. DCRC offers a transitional housing program designed to help families safely and effectively move into violence-free living. Through the program they can receive counseling, financial literacy education, employability skills training and other educational programming. Clients are able to select their own housing within the community as a means of promoting self-empowerment.
