Scholarships: In 2016, 766 students received scholarships that included tuition, books, supplies. Most scholarships are need-based and a few are merit-based. The objective is to help ensure access to college for all qualified Alamance County residents. In-kind contribution of \$227,986 provided expenses for shared employees who are employed by Alamance Community College.

Other Financial Aid: In addition to scholarships, ACC Foundation provides funds for ACC Work Study Program and an emergency distress program to prevent meritorious students from dropping out due to a one-time emergency situation. The ACC Foundation also runs a student ambassador program that provides leadership skills to selected students and opportunities to meet with college and community leaders. In 2016-17, 194 students received non-scholarship forms of financial aid. The objective is to help ensure access to college for all qualified Alamance County residents.

Education-related and Programs for Faculty and Staff: ACC Foundation provides funds to enhance the educational experience for students. ACC Foundation provides funds to faculty and staff to obtain additional training and hold professional memberships. Approximately 200 employees benefit and the objective is to ensure faculty and staff are current in their fields and are best able to meet the learning needs of an extremely diverse group of students. Also, ACC Foundation stewards donor designated funds to enhance the equipment and facilities for particular programs. Examples: Nursing, Medical Lab Technician and Culinary.
