THE ROOFTOP GARDEN TEACHES URBAN FARMING FROM A PARTNERSHIP WITH TRULY LIVING WELL AND GROWING ORGANIC VEGETABLES FOR HARVESTING AT PEACHTREE-PINE. OUR STUDIO AND GALLERY PROVIDE A WORK SPACE FOR CREATIVE ACTIVITIES FOR RESIDENTS AND OTHERS AT RISK OF HOMELESSNESS TO CREATE ART WORKS IN ALL MEDIA AS WELL AS TO EXPOSE THAT CREATIVITY TO THE PUBLIC TO DE-MYTHOLOGIZE HOMELESSNESS. WE ARE ALSO PREPARING FOR THE COMPLETION OF OUR CAFE. THIS CAFE PROVIDES A TRAINING AND MEAL-PREPARATION FACILITY THAT CURRENTLY ENABLES 50+ FAITH COMMUNITIES AND OTHER GROUPS TO PROVIDE EVENING MEALS, ECT.
