CSBG : Total grant provided revenues of \$1,822,784 The recognized expenses totalled 1,822,784- \$1,480,426 for program Expenses ; \$342,358 for management and General Expenses) All the funds received were spent. No fixed assets were capitalized. The program supports services that prevents homelessness and hardship due to delinquency in rental and utility expenses payments. It also provides educationl and life-skills trainings, such as budgeting and energy conservation. The CSBG grant generally supports most of the other programs and services of the agency. One thousand four- hundred- eighty (1,480) individuals were served in this fiscal year.

LIHEAP: The federal revenue amount of \$4,404,322 was received during the year. State funded energy program of \$83,514, was spent under this program. This brings the total revenue under this program to \$4,487,836. Total expenditure is \$4,481,227 (\$4,421,136 for program Expenses, \$60,091 for Management and General expenses). This is an energy program which targets eligible low-income households and assist them in the direct payments of their energy bills to avoid disconnections and hardship. During the year, 12,359 households were served.

UNITED WAY. This is a non-contractual partnership agreement with the United Way. Clients are referred to the agency for clients assessment.
