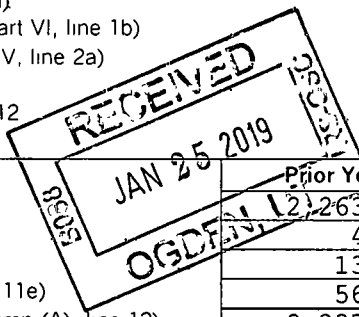

The Clinic operates a standalone free clinic with an in-house pharmacy located in Cabarrus County. The Clinic provides healthcare and pharmacy services to low-income, uninsured, working aged adults who have chronic health conditions (i.e., high blood pressure, diabetes, heart disease) and other primary medical care needs. Clinical and pharmacy services are provided three days and one evening each week. The Clinic's records indicate that the Clinic served 969 clinic patients with 3,119 clinic appointments. The Clinic pharmacy filled 12,019 prescriptions. The Clinic and pharmacy was also supported by 108 volunteers contributing 2,469 hours. The Clinic also provides patient eligibility, enrollment, and care coordination services for over 900 Cabarrus County adult residents who are low-income and uninsured. This service is part of Cabarrus County's health care safety net program, HealthNet.
