Service delivery relies much more on employee integrity because of the nature of the staff that provides services (people who also have disabilities). These staff members may at times request to access service opportunities such as peer support, information, and referral sources. Historically, the same application process is completed for all applicants for services (to include employees) and therefore all are subject to the same waiting periods. In addition, Human Resources routinely addresses policies and gives examples of potential conflicts of interest through internal communications provided to employees on a weekly basis.</p>
