The organization recognizes that for a conflict of interest policy to be effective a certain level of self-monitoring and professional ethics must exist within the governing body and employees themselves. As a small organization, governing decisions often have a personal impact on board members. In such cases, the executive director and board president take the initiative to disclose such and note that the potential director to whom the conflict relates will abstain from any vote. Service delivery relies much more on employee integrity because of the nature of the staff that provides services (people who also have disabilities). These staff members may at times request to access service opportunities such as peer support, information, and referral sources. Historically, the same application process is completed for all applicants for services (to include employees) and therefore all are subject to the same waiting periods.
