HOUSING ("BUILDING STRONG COMMUNITIES ONE FAMILY AT A TIME" CAPITAL CAMPAIGN) THE "BUILDING STRONG COMMUNITIES ONE FAMILY AT A TIME" CAMPAIGN, CONTINUED IN 2015 WITH THE COMPLETION OF THE THIRD SIX-UNIT APARTMENT HOMES AND THE COMMUNITY CENTER. THE APARTMENT CONSTRUCTION WAS IN PARTNERSHIP WITH HOME AID ATLANTA SAVING RAINBOW VILLAGE APPROXIMATELY 150,000. IT WAS THE LARGEST HOME AID PROJECT TO DATE AND WAS VERY SUCCESSFUL. THE COMMUNITY CENTER AND THE APARTMENTS FOR SIX ADDITIONAL FAMILIES INCREASING OUR VILLAGE TO 18 HOMES OPENED IN JUNE 2015. A RIBBON CUTTING CEREMONY WAS HELD WITH OVER 200 FRIENDS, FAMILIES AND SUPPORTERS OF RAINBOW VILLAGE IN ATTENDANCE. THE NEW HOMES WERE OCCUPIED BY JULY. THE COMMUNITY CENTER OPENED IN AUGUST ON THE FIRST DAY OF SCHOOL TO WELCOME OUR CHILDREN AND YOUTH TO ANOTHER YEAR OF AFTER SCHOOL PROGRAMMING. THE FAMILIES MEET IN THE COMMUNITY CENTER FOR EVENING PROGRAMS AS WELL. A BOUTIQUE SERVES THE RESIDENTS AND POST GRADUATES WITH THEIR CLOTHING NEEDS AND A CHAPEL IS PROVIDED FOR QUIET REFLECTION. THE EARLY CHILDHOOD DEVELOPMENT CENTER WHICH IS HOUSED ON THE FIRST FLOOR OF THE COMMUNITY CENTER OPENED IN NOVEMBER TO SERVE RESIDENT AND POST RESIDENT FAMILIES AND OTHER COMMUNITY CHILDREN.

4b (Code) (Expenses \$ 77,798 including grants of \$) (Revenue \$)

ADULT PROGRAMS AND SERVICES (SAFE HOMES IN A SAFE COMMUNITY) 23 FAMILIES COMPRISED OF 23 ADULTS AND 32 CHILDREN RESIDED IN RAINBOW VILLAGE'S THREE BEDROOMS, TWO BATH APARTMENT HOMES IN 2015. 99% OF THE EIGHT FAMILIES THAT COMPLETED THE PROGRAM IN 2015 SECURED AND MAINTAINED HOUSING WITHOUT SUBSIDY. AN AVERAGE WAGE INCREASE OF 967 PER MONTH WAS ACHIEVED. A PARTNERSHIP WITH MOVERS AND SHAKERS ENSURES THAT FAMILIES HAVE THE HOME FURNISHINGS THEY NEED WHILE LIVING AT RAINBOW VILLAGE THAT MOVE WITH THEM. THIS PROVIDES STABILITY AND CONTINUITY OF CARE DURING THEIR TRANSITION TO A HOME OF THEIR OWN. AN ALUMNI PROGRAM CONTINUES TO FOSTER THE LIFE SKILLS THEY HAVE LEARNED AND EMPOWERS THEM TO MENTOR OTHERS IN RESIDENCE. A FIVE YEAR INDIVIDUAL SERVICE PLAN IS DEVELOPED WITH EACH FAMILY. STATISTICS, AND OUR OWN 24 YEARS OF EXPERIENCE, HAVE PROVEN THIS TO BE THE AVERAGE LENGTH OF TIME REQUIRED FOR FAMILIES TO OVERCOME THE EMOTIONAL AND FINANCIAL BARRIERS TO HOMELESSNESS. THE ALUMNI PROGRAM PROVIDES SUPPORT FOR THE FINAL YEARS OF THE COMPLETION OF THEIR PLAN. AS A TRAUMA INFORMED CARE AGENCY, RAINBOW VILLAGE PROVIDES CASE MANAGEMENT, FINANCIAL AND MENTAL HEALTH COUNSELING AND LIFE SKILLS TRAINING TO ALL ADULTS.

CHILDREN AND YOUTH PROGRAMS (EDUCATION AND SUPPORTIVE SERVICES FOR HOMELESS FAMILIES WITH CHILDREN) ENRICHMENT PROGRAMS OF THE AFTER SCHOOL PROGRAM INCLUDED TUTORING, HOME ECONOMICS, ARTS & CRAFTS, SCIENCE, LITERACY (READING CHALLENGE), GWINNETT COUNTY FIRE DEPARTMENT - FIRE SAFETY, SEIZURE TRAINING, AND KHAN ACADEMY. PROGRAM FIELD TRIPS INCLUDED BOWLING, MOVIES, COUNTY PARK ACTIVITIES, CHILDREN'S PERFORMANCE PLAY AND GWINNETT BRAVES BASEBALL GAME. THE NUMBERS OF CONSISTENT, REGULARLY SCHEDULED VOLUNTEERS WERE 42 FOR THE AFTER-SCHOOL PROGRAM, THE NUMBER OF TOTAL VOLUNTEERS FOR THE AFTER-SCHOOL PROGRAM WAS 357 RESULTING IN APPROXIMATELY 2000 VOLUNTEER HOURS. VOLUNTEERS PLAYED AN IMPORTANT ROLE IN THE AFTER-SCHOOL PROGRAM. THE STAFF AND VOLUNTEER TO STUDENT RATIO IS APPROXIMATELY 1:4 WHICH CREATED A POSITIVE UNIFIED IMAGE, ESTABLISHED FRIENDLY RELATIONS AMONG STAFF MEMBERS AND STUDENTS, AND MOST IMPORTANTLY - MAKING A DIFFERENCE IN THE LIVES OF CHILDREN AND EMPOWERING THEM TO LIVE TO THEIR FULL POTENTIAL AND EXCEL IN SCHOOL AND LIFE. 50 CHILDREN AND YOUTH (RESIDENTS AND PROGRAM GRADUATES) ATTENDED ALL WEEKS OF SUMMER CAMP AT A COUNTY PARK. THEY ALSO ATTENDED FALL AND WINTER CAMP SESSIONS AT PLEASANT HILL PRESBYTERIAN CHURCH (STAFF DIRECTED) AND THE ROBERT FOWLER YMCA. EVENING ACTIVITIES INCLUDED "BIG RECESS" FUN AND GAMES, CHARACTER BUILDING AND SHARING IN FAMILY MEALS, BIRTHDAYS AND SPECIAL OCCASIONS. CHILDREN AND YOUTH ARE SEVERELY IMPACTED BY THE TRAUMA OF HOMELESSNESS. MANY ARE ONE TO TWO GRADE LEVELS BEHIND AT ENTRY. THEY ARE NOT VULNERABLE, NOT TRUSTING AND FEELING ABANDONED AND ISOLATED. BEING IN A NURTURING ENVIRONMENT WITH OTHERS STRUGGLING WITH SIMILAR LIFE CIRCUMSTANCES ALLOWS THEM TO LEARN TO TRUST, RELATE TO THEIR PEERS AND BUILD HEALTHY RELATIONSHIPS WITH OTHERS IN THE COMMUNITY. COUNSELING AND PROGRAMS ARE DESIGNED TO ASSIST THEM IN BREAKING THE CYCLES OF HOMELESS, POVERTY AND DOMESTIC VIOLENCE FOR FUTURE GENERATIONS. THE YOUNGEST MEMBERS OF OUR COMMUNITY (SIX WEEKS TO FOUR YEARS) ARE NOW RECEIVING A QUALITY EARLY CHILDHOOD DEVELOPMENT PROGRAM IN THE RAINBOW VILLAGE COMMUNITY CENTER. THEY WILL BE PREPARED TO CONTINUE THEIR EDUCATION IN SCHOOL AT THEIR PEER LEVEL DUE TO THE EDUCATION RECEIVED. THE EARLY YEARS OF DEVELOPMENT ARE CRITICAL FOR SUCCESS IN LIFE AND WE ARE COMMITTED TO ENSURING THAT OUR CHILDREN AND GRADUATE FAMILIES' CHILDREN RECEIVE EXCELLENT CARE AND EDUCATION. EXCELLENT LEADERSHIP, STAFF AND PROGRAMS ENSURE THAT ALL RAINBOW VILLAGE CHILDREN AND YOUTH ARE WELL CARED FOR AS THEIR PARENTS CONTINUE ON A CAREER TRACK THAT WILL SUSTAIN THEIR FAMILIES.
