Administered the WK Kellogg Foundation Grant. The focus of the grant is to develop new Early Learning Standards, Kindergarten Entry Assessment, and Family Engagement Guidelines for Arkansas. A State Parent Coordinator was hired to coordinate activities for the Family Engagement Committee. Two committees have been formed to support the project: The Early Learning Standards Committee which has 31 members began meeting in November, 2014. The Family Engagement Committee which has 18 members held their first in December, 2014. Consultants have been contracted with to support the activities for the project. The committees have completed their work with creation of both documents. Ongoing training is offered on both documents. New funding was provided to support school readiness. Twelve teams are participating in the School Readiness Summit
