THROUGH TWO GOOD VOCATIONS COMMISSARY CONTRACTS AT RAFB AND FORT GORDON, WORKERS STOCKED MORE THAN 1 MILLION CASES OF GROCERIES. THE RAFB CONTRACT, FIRST SIGNED IN 1980, WAS THE FIRST OF ITS KIND IN THE UNITED STATES; THE FORT GORDON CONTRACT HAS BEEN IN PLACE SINCE 1995. ADDITIONALLY, GOOD VOCATIONS CUSTODIAL SERVICE EMPLOYEES, WHO ARE CERTIFIED BY THE CLEANING MANAGEMENT INSTITUTE, ARE RESPONSIBLE FOR CLEANING MORE THAN 1.56 BILLION SQUARE FEET OF SPACE PER YEAR AT RAFB AND FORT GORDON.
