Founded in 1998 as a food pantry, the ministry name was Papa's Pantry. Through the early years of taking food to people's homes, we realized that taking food to people was the easy part. There were very real underlying circumstances to WHY people could not afford to feed their families. Mostly, it was that people needed jobs. We also discovered a great need to teach people how to manage money once they did have an income. Stability training began then in living rooms and kitchen tables. We saw firsthand, that these strategies worked, and people no longer needed help from food pantries or social services. Approximately 14,613 individuals received food assistance in 2019.

The Master's Training Center is the Educational division of Encompass Ministries. Over the years, the training programs have grown from the original employment and budgeting programs. Today, in addition, we offer training on computer literacy, goal setting, time management, nutrition/ healthy eating, financial literacy (beyond household budgeting), couponing, organic gardening, and bible studies. Life skills topics expanded for Addictions Recovery, Victims of Domestic Violence, Transitional Housing, and At-Risk-Youth programs include toxic relationships, boundaries, effective communication, and stress management. Approximately 429 individuals received training assistance.

My Community Spirit is a bi-monthly magazine, the Advocacy piece to the community for Encompass Ministries. It contains stories of client struggles and successes as well as educational topics. MCS will warm your heart, make you laugh, and encourage your spirit. Distribution includes hard copy bulk mailing and local distribution, as well as emails to approximately 2000 subscribers.
