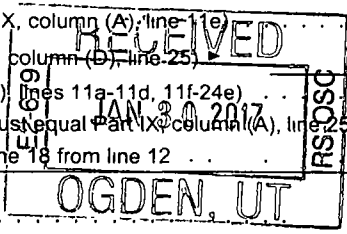

Emergency Shelter for Battered Women - This program assists victims of domestic violence and the community in coping with these crimes; to help medical personnel in delivery of health care needed by the victims; to provide counseling toward healing the emotional trauma experienced; to provide a safe environment to victims of domestic violence; and to educate the general public on domestic violence and its prevention. The agency served 487 clients. There were 21,900 meals prepared. Medical care was provided to 78 individuals. 36 temporary protective orders were obtained; 41 court appearances by staff and legal advocacy was provided for immigration assistance to 26 clients. In addition, IWH staff conducted 47 community presentations on domestic violence sexual assault and human trafficking.
