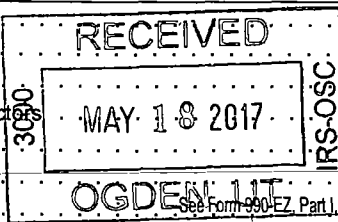

In April 2016 FACDC commenced operating a Food Pantry for for people in Metro Atlanta facing food insecurity and hunger at Twelve thousand (12,000) persons were served during 2016.

Pt III, Line 31

REAP Program FACDC operated a rent and energy assistance program (REAP) providing qualified individuals a one-time cash payment that will assist low to moderate income families in paying home heating and/or rent. Two families were served during 2016.

Pt III, Line 31

Making a House a Home Program: FACDC in partnership with Furniture Bank of Metro Atlanta provides clients/students the opportunity to receive furniture. The program main target groups are families disrupted by domestic violence. Five families were served during 2016.

Pt III, Line 31

Creation Care Program - To promote healthy living through our natural park that features nature trails and sitting areas of peace, meditation and tranquility. Our green space includes a community garden, walking trails, and playgrounds to encourage various levels of physical activity. Our working garden offers healthy foods and herbs to the community and also serves as a year round teaching garden partnering with local schools to educate the next generation on life science, agriculture, and entrepreneurship opportunities in urban gardening. In the case of adults the program involves, gardening tips, classes, hands-on experiences for maintaining their own garden onsite or at home. Each year Creation Care sponsors a Farmers Market as we strive to partner with other growers and farmers to bring an awareness of how healthy food is grown, prepared, and marketed for business purposes. The program served 125 persons.
