Georgia ACT carried out a number of activities in 2016, in furtherance of our mission to build and support a statewide network of thriving member organizations and trained professionals engaged in housing and community development serving families with limited housing choices Georgia ACT, through our membership in the National Alliance of Community Economic Development Associations sent one CDC representation to Dallas, Texas, all expenses paid to participate in the launch of the new 500 Cities Project dataset The 500 Cities Project is an initiative of the Robert Wood Johnson Foundation in collaboration with the Centers for Disease Control and Prevention and the CDC Foundation The new dataset provides local health data at the census-tract level for 500 of Americas largest cities The Foundation hopes that cities and their partners will use these new indicators at the census tract level to identify local health disparities and develop solutions to address them To support professional development of housing counselors, we sponsored a one-day training workshop, HUD Counseling Requirements, in two different locations, Macon and Atlanta, to make it convenient for housing counseling agencies to send staff We also delivered two webinars, Lending Lingo and Fair Housing The one-day training provided an overview of HUD housing counseling requirements, reporting via HUD Form 9902, how to track and record outcomes and impacts, and the all-important HUD billing This workshop met requirements as continuing education for the National Industry Standards, which requires that counselors complete a minimum of 10 hours of continuing education annually in subjects relative to the core content and delivery of homeownership counseling Attendees received a certificate of completion as official proof of course completion The two webinars consisted of 90 minutes of interactive presentations with polling questions and participatory activities Lending Lingo featured the loan estimate and closing disclosure with a laymen's interpretation of nearly every line plus tips about how consumers can evaluate APR's when making credit decisions The webinar also included a presentation on some key FHA loan products that HUD certified counselors should be aware of, so when the certification exam is finalized the counselors should have increased confidence about them Participants had to complete the post-test in order to earn their certificate The Fair Housing webinar included presentations on the historical timeline of events which shaped fair housing legislation, the Fair Housing Act, and fair housing exemptions Participants again received continuing education credit and a certificate of completion In the Fall, we held our annual housing conference with representatives from nonprofit housing and community development organizations from throughout the state, financial institutions, regulatory agencies, academia, and local and state governments The conference had two tracks one for nonprofit housing developers and one for housing counselors Sessions for the former addressed gentrification, fair housing, and financing through CDFIs Sessions for housing counselors featured presentations from HUD, Freddie Mac, and the Federal Housing Finance Agency Georgia ACT supported the formation of a coalition of several Community Development Financial Institutions (CDFIs) operating in Georgia The coalition came together to provide capital to support affordable housing across Georgia, increase the capacity of its members, and foster cooperation and collaboration among non-profit real estate focused CDFIs serving Georgia Georgia ACT contracted with a consultant to provide technical assistance to the coalition while in its formative stage Through partnerships, we provided scholarships made available through NeighborWorks America Southern District to each of the quarterly week-long NeighborWorks Training Institutes held in various parts of the country We participated with Enterprise Community Partners and the Georgia Department of Community Affairs in developing and implementing the Atlanta Preservation Challenge, a competition to develop strategies for preserving existing affordable housing, whether subsidized or naturally occurring In early November, after months of planning, the partners launched the Challenge with almost 100 people attending the announcement and a deadline for applications in January 2017 The winner will be selected in a two-stage process, with selection of three finalists and then the winner to be selected in May 2017 Metro Fair Housing Services made a grant to Georgia ACT to administer a down payment assistance program targeted to Southwest Atlanta and South DeKalb County, areas with a high number of foreclosures, resulting in devalued properties The concentration of foreclosures had ravaged the targeted communities with abandoned properties Georgia ACT anticipates providing down payment assistance to up to 33 homebuyers with household income of 80 percent or less of area median income Georgia ACT served as Grants Administrator for the Summerhill, Mechanicsville, and Peopletown (Atlanta inner city neighborhoods) Community Fund, Inc We reviewed and evaluated applications from community-based nonprofit organizations and oversaw award of nearly a quarter million dollars in grants Monitored performance of grantees and made regular reports to the Community Ford board Georgia ACT also orchestrated delivery of peer technical assistance to a nonprofit housing organization in South Georgia We distributed an e-newsletter at least twice a month with information on resources, federal and state legislation and policy issues, and future events (conferences, training opportunities, etc)In addition to these activities, Georgia ACT also participated in a number of collaborative initiatives or partnerships Participated in a disability rights coalition, Shut Out, Priced Out, and Segregated (SOPOS), dedicated to expanding housing opportunities for persons with physical disabilities Served on the Housing and Demographics Research Advisory Board of the University of Georgia Participated in the TransFormation Alliance, a coalition of organizations interested in linking communities around transit to promote equitable transit-orient development (TOD) in the Atlanta region In late 2016, the Strong, Prosperous, and Resilient Communities Challenge (SPARCC) selected the TransFormation Alliance to participate in a new initiative created to capture the opportunity of catalytic regional investments, so that people of all races and incomes benefit SPARCC is an initiative of Enterprise Community Partners, the Federal Reserve Bank of San Francisco, the Low Income Investment Fund, and the Natural Resources Defense Council, with funding support from the Ford Foundation, The Kresge Foundation, and the Robert Wood Johnson Foundation Over the course of three years, SPARCC will invest \$20 million in grants, programmatic support, and technical assistance and deploy upwards of \$70 million of capital in Atlanta and five other regions across the nation to address the rising tide of inequality in the places we live SPARCC supports regional leaders community members, local practitioners, policymakers, and investors who are collaborating to keep racial equity, health, and climate resiliency front and center as they engage in critical regional development opportunities By supporting locally driven approaches, SPARCC will work to improve the places where people live, learn, work, and play Among other areas, the TransFormation Alliance will focus on promoting an increase in the supply of affordable housing with its SPARCC funding Georgia ACT also engaged in advocacy targeted to programs administered by the Georgia Department of Community Affairs Prepared and submitted comments to the Georgia Department of Community Affairs (DCA) on its Consolidated Plan, promoting more flexible policies to support participation by nonprofit organizations working in marginalized communities After much research and analysis, published an extensive report on the States administration of the HomeSafe Program, funded through the U S Treasury Departments Hardest Hit Fund The report noted the slow expenditure of funds and included several recommendations for modifying the existing activities eligible for funding under the program as well as major expansions to benefit additional low to moderate-income homeowners facing foreclosure Retained a policy analyst to monitor proposed housing-related legislation at the State Capitol
