Clinical Services - We provide affordable, quality family planning services for women of childbearing age who are in need. The population served is low-income and uninsured or under-insured women with limited access to family planning services. Low-income and minority women have greater difficulties than other women in avoiding unplanned pregnancy due to the disparities in access and affordability to critical preventive services. Making sure that contraceptives are affordable and accessible for economically vulnerable female-headed households with children and/or girls from economically vulnerable households is one of the best ways to help this high-risk group avoid unintended pregnancy. Sexual and reproductive health and delaying child-bearing are important components of a healthy life for women. They lead to broader choices in life, empowerment and a chance to escape from the poverty that afflicts so many of the world's women. The Organization's goal is that women optimize their health, make healthy choices and have access to quality family planning services when they need it. We deliver care based on a community health center model, where clients can walk into our health center without an appointment and be seen at any time during office hours. Our fee scale reduces the financial barrier to low-income and uninsured women, assuring access to women in need. Clients are asked their income level and family size, and the fee is determined based on where they fall on the Federal poverty level table. We accept Medicaid and commercial insurance if the client has it. (And it is important to note that even our full fee is only 65% of a private physician's office.) Our health centers also provide basic gynecological care including physical exams, birth control methods, cancer and hypertension screening, sexually transmitted disease testing and treatment, HIV testing and counseling, medical referral, and health education and promotion.
