The University believes that it is no longer subject to U.S. federal, state and local, or non-U.S. income tax examinations by tax authorities for years before 2012. However, the University is still open to examinations by taxing authorities from fiscal year 2012 forward. For year ended June 30, 2017 and 2016, there was no interest or penalties recorded or included in the consolidated statements of activities. Earnings from unrelated business activities were not significant for the years ended June 30, 2017 and 2016. Accordingly, no provision for income taxes has been made in accompanying consolidated financial statements.</p>

The violation of this policy is a serious matter and may result in the removal of the trustee from the board or the termination of the president's contractual relationship with the university. If the ECA has reasonable cause to believe that a covered employee has failed to disclose one or more covered relationships, it shall inform the covered employee of the basis for such belief and afford the covered employee an opportunity to explain the alleged failure to disclose. If, after hearing the response of the covered employee and making such further investigation as may be warranted in the circumstances, the ECA determines that the covered employee has in fact knowingly failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action as it deems proper in its sole discretion. The violation of this policy is a serious matter and may result in the termination of the covered employee's contractual relationship with the university.
