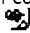





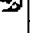
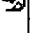

FAMILY WELLNESS SERVICES - HAVING ACTIVELY JOINED IN THE FIGHT AGAINST BREAST AND CERVICAL CANCER SINCE 1994, THE FAMILY WELLNESS PROGRAM PROVIDES MUCH NEEDED HEALTH SERVICES FOR FREE OR AT A MINIMAL CHARGE TO UNINSURED MINORITY INDIVIDUALS LIVING IN MIAMI-DADE, BROWARD, AND MONROE COUNTIES. THE PROGRAM PROVIDES CLINICAL BREAST EXAMS, ANNUAL SCREENING MAMMOGRAMS, CERVICAL SCREENING, FOLLOW-UP APPOINTMENTS, DIAGNOSTIC EXAMS, EDUCATION, CASE MANAGEMENT, AND SUPPORT SERVICES SERVING AN ESTIMATED 381 INDIVIDUALS THROUGH DIRECT SERVICES AND ONLINE WORKSHOPS, COMMUNITY EDUCATIONAL EVENTS AND REFERRING AN ADDITIONAL 4,000 INDIVIDUALS LAST YEAR. WITH THE INCREASE IN SOCIAL DISTANCING AND DECREASE IN UTILIZING PREVENTIVE HEALTH CARE, WE INCREASED AWARENESS EFFORTS BY TEACHING PEOPLE OF THE INCREASED IMPORTANCE TO SCREEN FOR BREAST/CERVICAL CANCER BECAUSE OF COVID-19. IN ADDITION, YWCA HAS INCREASED ITS COMMUNITY OUTREACH AND PARTNERSHIPS. FOR EXAMPLE, FAMILY WELLNESS PROGRAM IN MAY 2021 YWCA SOUTH FLORIDA ENTERED INTO A PARTNERSHIP WITH BAPTIST HEALTH TO FOSTER VACCINE EQUITY IN VULNERABLE SOUTH FLORIDA COMMUNITIES. THE YWCA HAS CONTINUED TO IMPLEMENT A CULTURALLY RELEVANT APPROACH TO ENSURE THE WOMEN OF SOUTH FLORIDA CONTINUE TO RECEIVE LIFE-SAVING CARE. COURT CARE/KIDSPACE - YWCA COURT CARE/KIDSPACE IS A HUMAN RIGHTS RESPONSE PROGRAM LOCATED IN MIAMI-DADE AND BROWARD COURT HOUSES. YWCA PROVIDES SERVICE COORDINATION AND FREE, TEMPORARY CHILDCARE FOR AGES 6 MONTHS - 13 YEARS TO ENSURE PARENTS, MAINLY WOMEN, CAN FULLY PARTICIPATE IN RELATED COURT PROCEEDINGS OR FILINGS. MAINTAINING SIX CENTERS IN TOTAL; FIVE OF THE CENTERS ARE LOCATED IN MIAMI-DADE AND ONE IN BROWARD. OUR TRAINED, QUALIFIED YWCA STAFF SUPERVISE CHILDREN THANKS TO A PARTNERSHIP BETWEEN YWCA SOUTH FLORIDA, INC. AND THE ELEVENTH JUDICIAL CIRCUIT OF FLORIDA AND BROWARD COUNTY. OUR COURT CARE/KIDSPACE CENTERS PROVIDE CHILDREN WITH A POSITIVE AND NURTURING ENVIRONMENT AND FAMILIES WITH SUPPORT SERVICES; AND BOTH WITH AN APPROPRIATE AND RESPONSIVE REFERRAL SYSTEM SHOULD FAMILIES HAVE ADDITIONAL NEEDS. AS A RESPONSE TO COVID-19 WE AMPLIFIED OUTREACH SERVICES TO MEET THE INDIVIDUAL NEEDS OF THE 2,595 FAMILIES TRADITIONALLY SERVED IN THE COURT CARE/KIDSPACE PROGRAMS BY CONDUCTING WELLNESS CHECKS, OFFERING REFERRALS AND INFORMATION ABOUT COMMUNITY SERVICES THROUGH OVER 8,000 PHONE CALLS. CHILD CARE PROGRAMS PIVOTED TO VIRTUAL DURING FAMILY COURT TIMES TO ENSURE KIDS IN THE HOME REMAINED SAFE AND WERE NOT RETRAUMATIZED WHILE PARENTS PARTICIPATED IN VIRTUAL COURT CASES. RACIAL & SOCIAL JUSTICE - WE PROUDLY ESTABLISHED THE OFFICE OF RACIAL & GENDER EQUITY ADVANCEMENT TO LEAD SOCIAL JUSTICE INITIATIVES AND PROGRAMS THROUGHOUT THE COUNTY. ONE OF THESE WAS THE SECOND YEAR OF YWCA SOUTH FLORIDA'S 21-DAY RACIAL EQUITY & SOCIAL JUSTICE CHALLENGE, DESIGNED TO CREATE DEDICATED TIME AND SPACE TO LEARN ABOUT AND BUILD MORE EFFECTIVE SOCIAL JUSTICE HABITS. YWCA ADDRESSES DISCRIMINATION HAPPENING AT THE INTERSECTION OF RACE AND GENDER THROUGH ECONOMIC DISPARITIES, EDUCATIONAL INEQUITIES, AND LIMITED ACCESS TO HEALTH CARE. BY THE CLOSE OF JUNE 2021, THE PROGRAM HAD REGISTERED OVER 2,900 PARTICIPANTS. IN ADDITION TO THE 21-DAY RACIAL EQUITY & SOCIAL JUSTICE CHALLENGE, WE ENGAGED HUNDREDS OF PEOPLE THROUGH OUR VIRTUAL BEYOND 21 EVENTS AND OUR WEEKLY INSTAGRAM LIVE BROADCASTS, #TAKEACTIONTUESDAY. BEYOND 21 IS A PROGRAM THAT BUILDS ON THE SUCCESS OF THE 21 DAY CHALLENGE TO MAKE SUBJECT MATTER EXPERTS AVAILABLE TO OUR COMMUNITY AND FURTHER THE CONVERSATION AROUND SYSTEMIC RACISM IN OUR COUNTRY. #TAKEACTIONTUESDAY BROADCASTS ALSO PROVIDED AN OPPORTUNITY FOR THE COMMUNITY TO ENGAGE WITH SUBJECT MATTER EXPERTS AS WELL AS AN OPPORTUNITY FOR INDIVIDUALS TO SHARE THEIR UNIQUE EXPERIENCES AND PERSPECTIVES WITH A WIDER AUDIENCE THROUGH A RACIAL & GENDER EQUITY LENS. SOCIAL JUSTICE IN ACTION PROGRAMS - FROM EVENTS TO COMMUNITY ENGAGEMENTS, YWCA'S 1,210 VOLUNTEERS WERE COMMITTED TO SERVING AND SUPPORTING SOCIAL JUSTICE. VOLUNTEERS WORKED ON IMPROVEMENT PROJECTS, LEARNING EXPERIENCES OF OUR YOUNG STUDENTS, HELP CREATE AWARENESS AND SUPPORT VICTIMS OF SEX-TRAFFICKING OR MAKE FEMININE HYGIENE PRODUCTS MORE AVAILABLE TO HOMELESS WOMEN AND GIRLS. WITH THE PANDEMIC MOVING ALL PROGRAMS AND ENGAGEMENTS INTO A NEW VIRTUAL LANDSCAPE, SO DID OUR VOLUNTEER OPPORTUNITIES; YWCA APPEALED TO MANY VOLUNTEERS ACROSS THE STATE AND COUNTRY, WHO CREATED OVER 40 VIDEO STORY TELLING OF CHILDREN'S IN MULTIPLE LANGUAGES THAT CAN BE ENJOYED ONLINE IN THE SAFETY OF THEIR HOMES. YWCA SOUTH FLORIDA CENTENNIAL CELEBRATIONS - IN HONOR OF THE CENTENNIAL, YWCA HOSTED THREE (3) HISTORIC CELEBRATIONS: FIRST, BUT NOT THE LAST WOMEN LEADERS OF SOUTH FLORIDA DINNER EVENT HONORING 9 PIONEERING TRAILBLAZERS, LEGENDS REUNION BRINGING TOGETHER PAST DONORS AND BOARD MEMBERS, AND NEXT! THE VIRTUAL CENTENNIAL CELEBRATION CAPTURING THE HISTORY AND FOCUSING THE FUTURE OF THE ORGANIZATION. EVENTS WERE ATTENDED AND VIEWED BY OVER 1,500 TIMES COMMUNITY MEMBERS AND CAN BE VIEWED ON OUR YWCA YOUTUBE CHANNEL. MIAMI GARDENS DEVELOPMENT PROJECT - IN 2001, YWCA ACQUIRED PROPERTY LOCATED IN MIAMI GARDENS. THE PROPERTY IS APPROXIMATELY 9.75 ACRES IN SIZE AND CAN ACCOMMODATE UP TO 117,000 GROSS SQUARE FEET OF BUILDING SPACE. YWCA COMPLETED THE INTERGENERATIONAL CENTER DURING THE YEAR ENDED JUNE 30, 2017. DURING THE YEAR ENDED JUNE 30, 2019, YWCA ENTERED INTO A GROUND LEASE WITH 13 PISTA, LLC THAT WILL ALLOW TRANSFORMATIONAL REACH INTO THE MOST VULNERABLE POPULATION OF WOMEN, GIRLS AND FAMILIES. THIS PARTNERSHIP WILL BRING OTHER MISSION-ALIGNED NON-PROFITS, SPECIFICALLY HIS HOUSE, CENTER FOR FAMILY AND CHILD ENRICHMENT AND THE ARC TO OUR PROPERTY, CREATING A CAMPUS OF SOCIAL INNOVATION, WHERE WE WILL SERVE OUR COMMUNITY COLLECTIVELY IN OUR AREAS OF FOCUS.
