children were matched with a caring volunteer from the community for
professionally managed, one-to-one, site based mentoring. The
mentoring occurred an average of one hour weekly each week over the
course of the school year on location at the child's school. In
addition to the site based sessions, eligible site based matches were
invited to attend two group outings, sponsored by BBBSNEFL, over the
summer to maintain participant engagement and promote participant
satisfaction and thus retention rate in the subsequent FY. End of year
reports indicate advances were made by the majority of students engaged
in the program as they pertain to academic, behavior, and social
successes.

Community Based Program: During the course of the 2016/2017 fiscal
year, 368 children were matched with a caring adult volunteer from the

Florida. In addition to individual outings, the mentoring matches were
also provided with enrichment opportunities of educational,
recreational, and service orientations on a monthly basis. Reports
indicate advances were made by the majority of students engaged in the
program as they pertain to academic, behavior and social successes.
