Early Intervention- The Arc of Palm Beach County's First Step to Success program provides in-home services throughout Palm Beach County to families of children from birth to five years of age who demonstrate a mild delay in child development. The Arc's team of developmental specialists works with children and their families to strengthen children's skills in the areas of cognition, communication, movement, coordination, social/emotional and self-help. These specialists focus on supporting the parent/child relationship and helping the child achieve developmental milestones. The Healthy Steps to Success program provides developmental services in local pediatricians' offices bringing families and health care providers together to improve the health, development and emotional wellness of children from six months to age three. Services provided include a child development line, links to community resources, home visits, parent groups and more. The Forward Leaps Program provides short-term in home developmental support to children, birth to age 5, with minor developmental delays and provides parents with guidance to support developmental skills.

Form 990, Part III, Line 4b:

Residential Services - The Arc provides housing for adults who are developmentally disabled throughout Palm Beach County. These homes are designed to help adults over 18 acquire the skills necessary to enhance their quality of life and achieve their highest level of independence. These facilities are staffed 24 hours a day. Each resident has a personal plan that identifies goals and achievement strategies. During the day, every resident participates in a meaningful activity with many engaged in employment related activities. Moreover, rehabilitation services are provided that offer training activities to help residents acquire, maintain or improve upon skills related to daily living. These services focus on personal hygiene, homemaking and social skills to enable individuals to reside in the community.

Form 990, Part III, Line 4c:

Education - Potentials School is a tuition-free, independently run public school providing the best in education with integrated therapies in a safe, nurturing environment for exceptional children in Palm Beach County. The school provides intensive classroom learning experiences, as well as speech, occupational, physical and vision therapy for children from preschool through the eighth grade who have severe disabilities in the areas of communication and ambulation. Moreover, the school has the full support of the Palm Beach County School Board and is an active member of the Florida Consortium for Public Charter Schools.

Adult Education and Employment Services - The Career Transition Program (CTP) helps participants develop a wide variety of life skills which are necessary in the workplace and in the greater community. CTP participants may also engage in artisan activities, which allow them to utilize their creative talents to produce unique pieces of art which they sell for earned commission-based income. The Supported Employment coaches help developmentally disabled individuals who are seeking employment to obtain appropriate employment, work with them to master their job skills and provide ongoing support once they are hired.

Family and Respite Services - The Arc offers support and guidance to families to help them support their loved ones with developmental challenges. Family Services serves as the gateway to the agency, helping acquaint new families with all that The Arc has to offer. We provide advocacy, referral services and direct support for families who have children of any age with developmental disabilities. We link families to essential resources, events, workshops and support groups. The Respite Services Program has trained professional caregivers who provide short-term care that helps the family of a disabled child or adult take a break from the stress of their daily routine. The Respite Program offers in-home services and center based care.

The Community Inclusion Program promotes the appropriate involvement of elementary school children with disabilities in after school, summer camp and other out-of-school time programs across Palm Beach County.
