This contract provided 7,722 unduplicated elders persons and caregivers with services during 2019. The Alzheimer's Disease Initiative (ADI) program ensures that persons afflicted with Alzheimer's disease and other forms of dementia, are given essential services to help them age in place, in an elder-friendly environment, with security, dignity, and purpose.
