Each of these parties is related through common officers and/or directors. Housing Partnership, Inc. and Parent-Child Center, Inc. HPI and PCC share expenses for management and support services. Employees may work for one of the two organizations but provide services to both. As such, each organization reimburses the other for its proportionate share of resources used. During the year ended September 30, 2020, the net effect of these shared resources was a payment by PCC to HPI of \$217,126. There was no intercompany receivable for shared resources due to HPI at year end. Mortgage receivable from PCC for the Village for Change program, at an interest rate of 4.00% per annum, requiring monthly payments of principal and interest totaling \$1,691, collateralized by the property. The mortgage balance as of September 30, 2020 is \$6,966 and matures January 7, 2021.</p>
