WHILE LEARNING ABOUT VARIOUS JOBS, THE CHILDREN SEE HOW BASIC EDUCATIONAL SKILLS LIKE MATH AND READING ARE USED ON AN EVERYDAY BASIS IN JOBS. THE TEACHERS VERIFY THAT STUDENTS ARE MUCH MORE ENTHUSIASTIC WHEN THEY SEE HOW SKILLS THEY LEARN IN THE CLASSROOM ARE USED OUTSIDE THE CLASSROOM, IN THE REAL WORLD. THE SHADOW PROGRAM ALSO REINFORCES SOCIAL SKILLS, WHICH ARE AN INTEGRAL PART OF OUR EDUCATIONAL SETTING. EVERY GOOD TEACHER TRIES TO SIMULATE A REAL WORLD ENVIRONMENT IN THEIR CLASSROOM AND THAT'S WHAT WE'VE CREATED HERE. THE SMALL SCHOOL ATMOSPHERE, INDIVIDUALIZED ATTENTION, COUNSELING, AVAILABILITY OF STUDENT SERVICES AND SPECIALIZED INSTRUCTIONAL COMPONENTS TAUGHT BY THE PINELLAS COUNTY CERTIFIED TEACHERS FOSTER A DESIRE IN CHI CHI'S KIDS TO SUCCEED IN SCHOOL AND LIFE. FIRST TEE OF CLEARWATER PROGRAM THE FIRST TEE OF CLEARWATER IS ONE OF THREE TAMPA BAY AREA CHAPTERS AND SERVES OVER 3,000 PARTICIPANTS.
